Award Categories:

- **Excellence in Diversity Award** – An industry career achiever award honoring an individual that has exhibited visionary and insightful leadership to confront and resolve inequities through a high level of commitment to diversity and inclusion initiatives throughout their career, inspiring forward thinking and action in the communications industry.
- **Distinction in Communications Award** - An individual demonstrating a high level of accomplishment in his or her career and leveraging that success to influence advancement through collaboration in the areas of diversity and inclusion through the use of media and/or broadcasting.
- **Diversity and Inclusion Champion of the Year Award (Individual)** - An individual who champions equality within the communications industry, creating awareness, increasing engagement, retention, and advancement of people from diverse groups.
- **Diversity and Inclusion Champion of the Year Award (Organization)** - An organization that champions diversity and inclusion within the communications industry, as well as in the community, creating awareness, increasing engagement, retention, and advancement of people from diverse groups.
- **Excellence in Leadership Award** – An individual that has worked to promote and facilitate equitable education and social engagement with and between people of varying backgrounds and beliefs demonstrated by a stellar record of volunteering and raising awareness and commitment to diversity and inclusion within the communications industry. This leader's work is a reflection of their organization's commitment to celebrating and valuing individual differences that strengthens the organization.
- **Partner of the Year Award** – A non-operator organization that has consistently championed and supported diversity and inclusion efforts this year within the communications industry and throughout the Greater Texas market.

Nomination Criteria:

Eligibility:

- Honoree must be at a Manager level or above with at least five years in the communications industry.
- Must be employed in or serve the Texas market.
- Must not serve on the NAMIC-Houston Board of Directors or Awards sub-committee.

- Eligible submissions for entry must be received by 5pm (CST) on January 27, 2012.
- Nominations in multiple categories are accepted, however, only one category per entry.
